The growing global concern over radicalized employees with potential for violent acts, no matter what the impetus, has been the topic of discussion in many board rooms and executive suites.</p> <p>Together, these concerns have profound implications for corporate security, human resources and legal departments as the desire to secure the workplace runs up against resource constraints, internal turf battles, and privacy issues.</p>
